### **1. EU roadmap for the R&I nutrients initiative**

#### **Nutrients taskforce**


• DG RTD (Dir. I & F), DG AGRI, JRC

#### Rationale

- There is a need to improve nutrient management:
  - to ensure sustainability of agriculture and bio-economy,
  - and to prevent environmental and economic damages from nutrients losses/emissions
- Policy fragmentation

#### **Objectives**

- Input for the Strategic Research and Innovation Plan (2021-2024) and Work Programme (2021-22) for Horizon Europe
- Policy recommendations





# **2. Ongoing nutrient-related calls for proposals**

#### **HORIZON 2020**

- Societal Challenge 2 (deadline 23.01.19)
  - CE-RUR-08-2018-2019-2020: Closing nutrient cycles
    - Bio-based fertilisers from animal manure (~8M€)
  - SFS-23-2019: Integrated water management in small agricultural catchments (~14 M€)
  - CE-SFS-39-2019: High-quality organic fertilisers from biogas digestate (~5 M€)
  - CE-RUR-10-2019: Circular bio-based business models for rural communities (~20M€)



# Upcoming nutrient-related calls for proposals

#### **HORIZON 2020**

- Societal Challenge 2
  - CE-RUR-08-2018-2019-2020: Closing nutrient cycles
    - Bio-based fertilisers from other by-products of the agro-food, fisheries, aquaculture or forestry sectors (opens in 2020)

#### Societal Challenge 5

- CE-SC5-04-2019 Building a water-smart economy and society (open for applications 14.11.18-19.02.19)
- BBI JU
  - Annual Work Plan for 2019 will be adopted before the end of 2018



### **Circular Bioeconomy Thematic Investment Platform**

- What is it: Financial instrument providing loans and loans guarantees (no grants) to circular bio-economy projects. The instrument will be able to support high risk projects that would not be supported by commercial banks/investors.
- How will it operate: Part of the InnovFin instrument but run by a third party fund manager on EC behalf
- **Thematic scope:** Innovative bioeconomy projects (excl. bioenergy) in TRL 6-9
- **EU contribution:** EUR 100m from Horizon 2020 WP 2018 (half from Societal Challenge 2 and half from Access-to-risk finance)
- Latest development: Currently under development. Selection of fund manager ongoing (call recently launched, see: (<u>https://etendering.ted.europa.eu/cft/cft-</u> <u>display.html?cftId=4096</u>). Expected launch in 2020.

## Common Dissemination Booster (CDB) – Pilot 2017-2019

- Free of charge service from the European Commission to all ongoing and closed European, national and regional funded R&I projects (H2020, FP7 etc)
- Implemented by external consultants
- Services:
  - 1. Portfolio Identification
  - 2. Stakeholder/End-user mapping
  - 3. Portfolio Dissemination Plan Development
  - 4. Portfolio Dissemination Capacity Building
  - 5. Dissemination Campaign in Practice



## New Dissemination & Exploitation Boosters - 2019

- New procurement in progress (4-yrs FWC) offering number of similar and new types of D&E services to beneficiaries
- New calls for expression of interest to open beginning of 2019



## **Projects for Policy (P4P)**

- Review of EU funded projects across thematic clusters with the view to deliver:
  - Policy recommendations
  - Knowledge gaps -> Strategic Research and Innovation Plan for Horizon Europe
- P4P on nutrients expected in 2019





## H2020 Dashboard

- Frequently refreshed, one click stop shop for H2020 data
- Modern visual analytics (data discovery tool)
- Complete picture (data on proposals, projects and results)

## CORDIS

- The point of reference to seek information on EC funded research projects, public available
- Focus on dissemination
- Products and services offered:
  - Publishable summaries for H2020
  - Results Packs
  - Enhanced Results in Brief
  - H2020 public deliverables and Publications
- Offers support for accessing Open Air results (search interface):
